FAIRFIELD COUNTY FAMILY, ADULT AND CHILDREN FIRST COUNCIL MISSION

In the pursuit of a better quality of life for the families, adults and children of Fairfield County, it is the vision of the Council to create and facilitate a coordinated system of services that responds to the strengths and needs of our community.

The Fairfield County FACF Council is a partnership of public and private non-profit child and family-serving agencies and organizations committed to improving the wellbeing of children and families. The Council facilitates a local community collaborative to:

- Streamline and coordinate government services for families seeking help for their children;
- Develop and implement a service coordination mechanism to prioritize services and fill gaps where possible;
- Participate in comprehensive and coordinated interagency system for infants and toddlers with developmental disabilities or delays;
- Monitor progress toward achieving results;
- Ensure input from families and from a broad spectrum of the community;
- Build community capacity.

The Council is steered by its Executive Committee, which includes representation from: parents, Board of County Commissioners, Mayor of the City of Lancaster, Educational Service Center, Pickerington Schools, Lancaster City Schools, New Horizons Mental Health, Fairfield County Board of DD, Job and Family Services, Child Protective Services, Fairfield Community Health Center, Early Childhood Programs of Lancaster-Fairfield Community Action Agency, United Way, Lancaster Community Development Department, Fairfield Health Department,

ADAMH Board and Juvenile Court. The Fairfield County Board of Commissioners is the FACF Council's administrative agent.

MULTI-SYSTEM YOUTH PROGRAM— CINDI WEST, MSY COORDINATOR COURTNEY CARLO, MSY PROGRAM ASSISTANT

The Multi-System Youth (MSY) program provides the service coordination system for multi-need youth that organizes agencies, people and services to support the individual needs of children and families. With the family's involvement, a coordinated service plan is formulated to increase efficiency and responsiveness to each family's unique needs. Service Coordination provides a broad and effective perspective by bringing all case managers and others important to family success to the table to collaboratively implement an approach that is efficient and effective. Fairfield County pools its resources and efforts to provide service coordination, as well as a broad range of support and evidence-based interventions.

Reducing out of home placements for high-need youths is one of the goals of this program. During FY 2020, 157 youth were served. Youth in out-of-home placement represented 5.7% of those served. Most youths exiting service coordination achieved all of the goals of their service plan.

HELP ME GROW EARLY INTERVENTION—TIFFANY WILSON, CONTRACT MANAGER

Help Me Grow Early Intervention (EI) serves children birth to three years of age who may have developmental delays and disabilities by providing assessments, evaluations, and coordinated services. Early Intervention program implementation partners are Lancaster-Fairfield Community Action Agency for service coordination and the Fairfield County Board of Developmental Disabilities for provision of services. We applaud the team for developing and implementing virtual processes to sustain services in the pandemic. The new virtual model meets the individualized needs of each family while protecting the health and safety of everyone involved.

El is an evidenced-based program that believes children learn best from familiar people in familiar settings. Every family in the El program has a service coordinator and service providers. An Individualized Family Service Plan (IFSP) is developed collaboratively. The team works in the child's natural environment, using the family's existing supports and resources to enhance the child's learning and development. Service Coordinators guide families through every aspect of the El process, from program entry until the child transitions out of the program by age three.

In SFY 20, 391 children were served. Most of the 203 children exiting the program transitioned successfully to preschool. Reports indicate that all children exiting demonstrated substantial progress with social and emotional skills, acquisition and use of knowledge and skills, and taking action to meet needs.

PARENT EDUCATION

COOPERATIVE—PAM REDDING, COORDINATOR

To meet families' needs of parenting support during the pandemic, virtual methods of service delivery were implemented to provide parent education classes and discussion groups through live-virtual and web-based platforms.

The parenting education curriculums and parent discussion groups provided to the community by the FACFC are made possible through the support of many partners, including the Fairfield County ADAMH Board, Lancaster Community Development Department, Fairfield County CDBG grant, Fairfield County Foundation, and South Central Power Foundation. Nationwide Children's Hospital sponsors Power of Positive Parenting—"Triple P" — discussion groups and brief interventions.

The Fairfield County Parent Education Cooperative meets quarterly to review availability, optimal scheduling, and gaps in population-specific education. This is an important advisory group to inform the direction of our parenting support activities in our community. We value and appreciate their willingness to offer their advice and expertise.

Parent education services include: The First Five Years, Active Parenting, Active Parenting for Stepfamilies, Loving Solutions, Parent Project, Positive Parenting Program (Triple P) Level 3 and Triple P Level 4, and Positive Parenting Brief Interventions. During FY 20, 208 parents completed one of the services offered.

The development and distribution of the quarterly Family Resource Calendar continued to be a priority for 2020. The resource guide is available on the Council's website, and 1,500 copies are printed each quarter and distributed throughout Fairfield County.

The Parent Education Coordinator prepared a Parenting Resource Guide for the Youth Homelessness Project of the Lancaster-Fairfield Community Action Agency. This project involved collaboration across a five-county homeless planning region to target pregnant homeless youth. The guide provides pregnant homeless youth—as well as all caregivers of children—information on

SAFE COMMUNITIES COALITION—KIRSTEN PERSINGER, COORDINATOR

The Safe Communities Coalition promotes safe driving practices and creates awareness of behaviors that prevent traffic crashes, injuries, and fatalities. Safe Communities Coalition initiatives are made possible through a grant from the Ohio Traffic Safety Office and in-kind support from local community partners.

This year, the Coalition applied for and received a State Farm Insurance Foundation grant to present a special event at Lancaster High School — ThinkFast[®] Interactive — a program that educated students on pedestrian and traffic safety in a fun and relaxed environment. This program engaged participants through Audience Response Technology.



When community events at which the Coalition planned to conduct outreach were cancelled due to the pandemic, virtual ways of reaching people with traffic safety messages were implemented. Coalition members presented two educational videos in March and August with support from many community volunteers who offered their time and resources. These videos focused on the National Highway Traffic Safety Administration's *Drive Sober or Get Pulled Over* theme. Despite the unforeseeable challenges presented by the pandemic, the Safe Communities Coalition increased its membership and was able to reach more people than ever through virtual technology. We are encouraged by reports that show increased seat belt use in Fairfield County. According to the University of Akron's 2019 observational

study, seat belt usage is 89.5%, up 2.7% from the 2018 study.

It is the volunteerism of community members and law enforcement that makes the Safe Communities Coalition successful in all efforts toward the goal of traffic safety in Fairfield County.

In FY 2020, seat belt use increased by 2.7% and 6,688 people were reached with key safedriving messages.



COMMUNITY INITIATIVES

Building Trauma Informed Systems (BTIS)

Driven by the collective understanding of the effect of child maltreatment and the ways that multiple systems can utilize brain research and best practice, this work group reviews the research and literature, learns from those in the field who are using the concepts of trauma-informed care and proposing both macro-educational opportunities as well as agency-toagency collaborations to work together for the best outcomes for children. The Committee presented a virtual community training conference this year. BTIS is chaired by Kim Devitt, Director of Lancaster-Fairfield Community Action Early Childhood Programs.

Fairfield County Perinatal Leadership Group

Chaired by Stephanie Fyffe, Director of Nursing at the Fairfield Department of Health, the Perinatal Leadership Group is addressing the issue of access to prenatal care for pregnant women who are actively using substances and the potential effects on infants. Efforts this year focused on compliance with the Comprehensive Addiction and Recovery Act for Plans of Safe Care for substance-exposed and substance-affected infants.

Fairfield County Housing Coalition

As the lead entity for the Continuum of Care planning process, the Fairfield County Housing Coalition provides a unified approach toward sustaining and improving local housing services for the homeless and low-income population. The Coalition has a diverse membership including service providers and community leaders that successfully collaborate in strategic planning to strengthen the system of care that serves the homeless and those at risk of homelessness. The Coalition conducts the Homeless Point-In-Time Count and fair housing training every year. Lynda Berge Disser, Executive Director of the Lancaster Community Development Department ,serves as Chair; Randall Hunt, Housing Director for Lancaster-Fairfield Community Action Agency, serves as Vice Chair.

Fairfield County Transportation Coalition

The Fairfield County Transportation Coalition convenes community members and transportation services providers to identify gaps and needs in services, and advocates for the provision of safe, affordable and accessible transportation. The Coalition also provides leadership in the development of the county's coordinated transportation plan. Carrie Woody, Director of Lancaster-Fairfield Public Transit, serves as President; Dr. Ed Payne, Executive Director & CEO of the Fairfield Center for disAbilities & Cerebral Palsy, serves as Vice President and Secretary.

Older Adult Network

The Older Adult Network is a collaboration among agencies, businesses, and organizations who serve older adults and their families in the community. Membership in the OAN is open to anyone who provides resources and services for the aging population and advocates for older adults. Co-Chairs are Linda McDonald & Nichole Speakman; Secretary is Kim Shook.

Community Trauma Conference Goes Virtual

When it was necessary to cancel the Annual Community Trauma Conference in the Spring due to the pandemic, the BTIS committee moved training to a virtual format featuring community experts. The series included the following:

- Heal Yourself to Help Your Kids with Jennifer Beckley-Watson, LPCC-S, Juvenile Court—Nov. 10.
- Understanding and Affirming of the LGBTQIA+ Community: Tools for Clinicians and Community Members by Cate Petrowski, PhD, Clinical Psychology—Dec. 1.



Early Literacy and Kindergarten Readiness Work Group

Dr. Marie Ward, Superintendent of the Fairfield County Educational Service Center organized the Early Literacy and Kindergarten Readiness Collaborative, convening educators, local government leaders, and the private sector to focus on Kindergarten preparedness. Emerging from these discussions, the multi-media "Say, Do, Know" campaign was conducted by Lancaster City Schools offering pointers to parents on ways to support Kindergarten readiness for their preschool-age children.

This past year, a snapshot of progress includes: units of recovery housing increased; the number of people employed through Fairfield County Board of DD programs has increased; declining homeless point in time count numbers have declined; Lancaster City Schools conducted a Kindergarten readiness campaign.
